I acknowledge, by signing this agreement, I am releasing Kids Unplugged, Inc. and its respective agents and affiliates, (collectively "releasees") from liability. This waiver and release is a contract with legal consequences. I have been advised to read it carefully before signing.

Kids Unplugged, Inc. Policies

- ♥ All kids participating in Kids Unplugged classes must be school-age (graduated from Kindergarten) and enrolled in a school.
- ♥ Payment and reservations must be made in advance.
- ♥ No electronic devices may be used at Kids Unplugged, but contacting a parent/guardian is allowed, as needed.
- ♥ No food or drinks from outside the facility are to be brought to Kids Unplugged, with the exception of water (please label with your kid's name). Water will be provided at regular intervals, and light snacks are included.
- ♥ You may drop your kids off up to 10 minutes before class. Please pick up your kids at the registration desk, within 10 minutes of class ending.
- ♥ To keep everyone healthy and safe, we ask that you NOT bring your kids to class if they are sick, have had a fever within 24 hours, or have had any recent exposure to a contagious disease.

1. I acknowledge and fully understand that I, or my child, will be engaging in physical activities that may involve some risk of injury. I acknowledge and have been advised that it is my responsibility to consult with my or my child's physician with respect to any past or present injury, illness, health problem or any other condition or medication that may affect my or my child's participation. I assume the foregoing risks and accept full personal responsibility for any personal injuries sustained by my child which might incur as a result of participating in this program and discharge and hold harmless Kids Unplugged Incorporated, its owners, directors, members, employees, and agents from any claim, cause of action or liability for damages arising from any personal injury to my child or other persons or property caused by myself or my child's participation in Kids Unplugged Inc.
2. I agree it is my sole responsibility to be familiar with the releasees' rules and any special regulations. I understand and agree that situations may arise which may be beyond the immediate control of the Releasees. I will comply with the requirements of any rules or regulations of Kids Unplugged Inc. My child has no physical or mental condition, which to my knowledge would endanger him/herself or others if he/she participates in this event, or would interfere with his/her ability to participate in this program.
